## Dear Crafter,

"Arts at Hayfield" is presently making plans for its 34th Homespun Holiday craft show which will take place on **Sunday, November 3, 2024, from 10:00 a.m. until 4:00 p.m.** (Exhibits must remain fully in place until 4:00.)

SPACES: The show is indoors (with occasional exceptions). The standard exhibit space is approximately 10'x10'. Non-standard spaces exist along walls and in the Commons. There are a limited number of spaces with access to electric outlets. Some outdoor spaces are available. Exhibitors are responsible for providing tables, extension cords, and display stands. If you have special needs regarding placement because of handicaps, electric outlet access, etc. please note these in the application.

APPLICATION NOTES: Your application is **due by June 30**. It should include <u>your completed application form</u> (below), a fee of \$60/space (made payable to ARTS AT HAYFIELD), **and at least three different photographs** that give us a clear picture of both the close-up quality and the general range of your work (and set-up if available). A return envelope is enclosed. Please feature no more than two or three categories of medium per entry. We can have a well-balanced show by avoiding many "overlapping" entries. Please be extremely specific in your description of the "nature of exhibit," (not just "fabric") *including a description of the material you use in your work and what your crafting consists of.* You may use the back of the form below or attach a description you already have if you need more space. All photographs will be returned (and also checks in the case of non-acceptance.) **Please note that all work exhibited must be the work of the applicant. No kits, commercially made products with slight embellishments, or products handcrafted by others are allowed.** Space locations are determined in advance of the show. **Please be sure to include pictures even if you were in the show before.** Final space notifications: hopefully by August 22.
